# Europe's National Minorities: Ways Forward for Minority Protection 'Ewald Ammende' International Expert Conference organised by FUEN

# Brussels 4-5 March 2024 Representation of the European Region Tyrol - South Tyrol - Trentino 47 Rue de Pascale, B-1040 Brussels

#### Context

We witness increasing restrictions on the use of national minority languages in some European countries. In 2021, the European Commission refused to initiate legislative action on any of the Minority SafePack European Citizens' Initiative proposals. In 2023 European Court of Human Rights' conclusion that education in a minority language – and the content of the Framework Convention on the Protection of National Minorities – are not part of 'a European consensus'. These are only some of the recent negative evolutions in the field of minority protection in Europe. We can surely state that minority rights protection is not stagnating in Europe, it is clearly going backward. This is surprising insofar as the examples of good minority protection in Europe all show that they have brought peace and prosperity and thus represent an advantage not only for the minority concerned, but for the entire granting state and that respect for the rights of persons belonging to a minority is, supposedly, one of the core European Union values if not of the entire European project.

## Primary goal

The 'Ewald Ammende' International Expert Conference organised by FUEN aims to discuss the current situation in order to reflect upon and formulate solutions for counteracting the grave regression in the protection of national minorities so as to enhance minority protection. Now is the time to recognise the grave dangers national minorities face and move forward to ensure their equal rights as well as new or stronger approaches to minority protection.
